RESOLUTION NO. 38-2014

A RESOLUTION TO AUTHORIZE THE CERTIFICATION OF THE PROPERTY TAX MILL LEVY TO THE EL PASO COUNTY ASSESSOR FOR THE BUDGET YEAR 2015 BEGINNING ON THE FIRST DAY OF JANUARY 2015 AND ENDING ON THE LAST DAY OF DECEMBER 2015

WHEREAS, the Board of Trustees of the Town of Monument has appropriated the necessary monies to fund the proposed budget by Ordinance; and

WHEREAS, the Division of Local Government and the Town Manager of the Town of Monument have determined the Tax Year 2014 (Budget Year 2015) "Statutory Property Tax Revenue Limitation" attached as Exhibit A; and

WHEREAS, it is necessary for the Board of Trustees to approve the property tax mill levy and to certify the same to the El Paso County Assessor.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF MONUMENT:


Section 1. Mill levy approved. The Property Tax Mill Levy for budget year 2015 shall be 6.289 mills, which will result in property tax revenues to the Town of Monument in the amount of \$695,100 during said budget year.

Section 2. Levy certified to County Assessor.


The mill levy of 6.289 mills is hereby certified to the El Paso County Assessor.
